

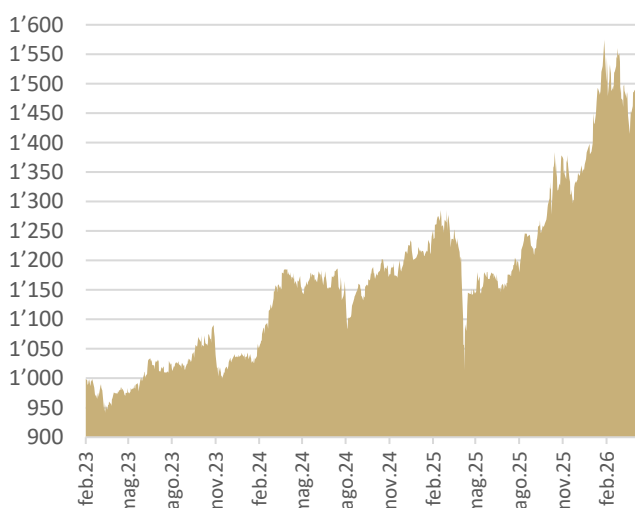

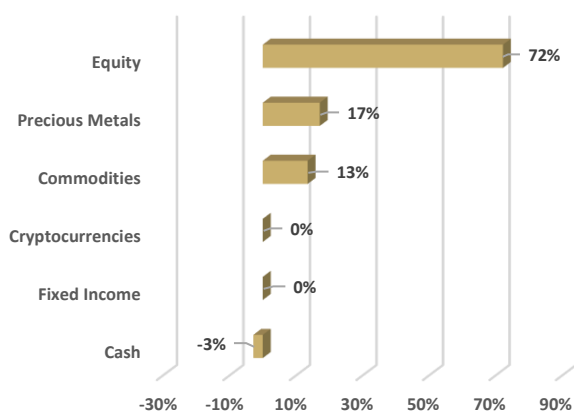
Price chart
