

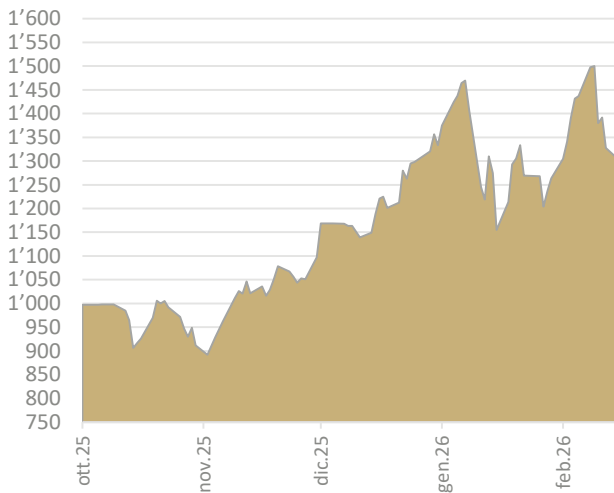

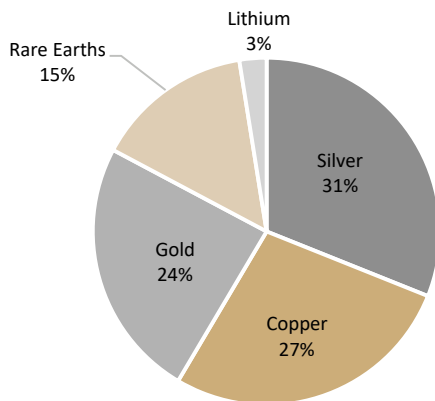
Price chart
