

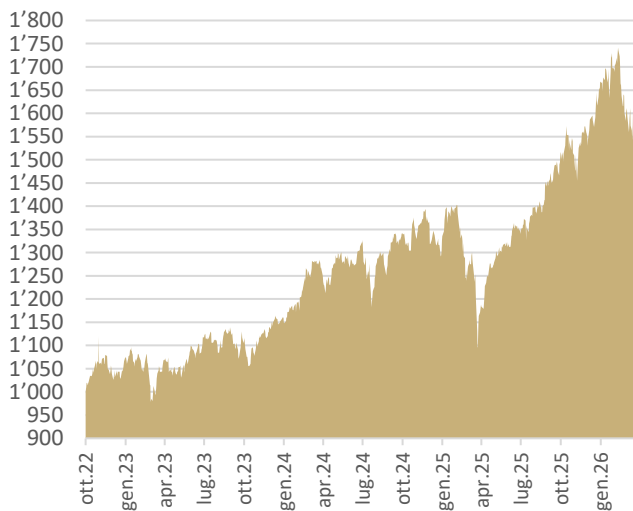

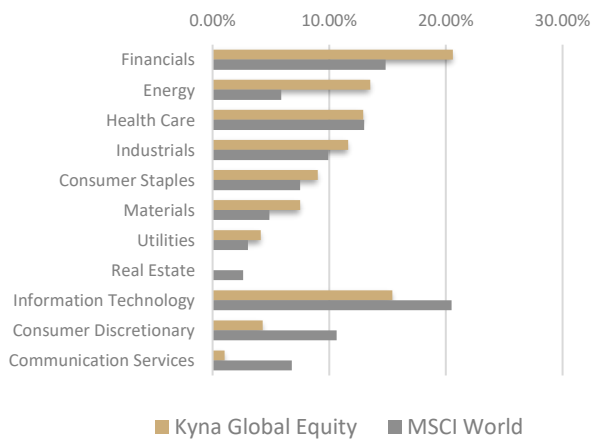
Price chart
