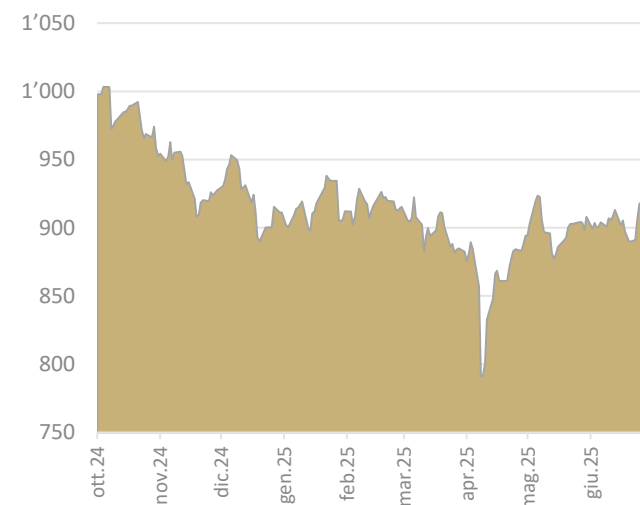

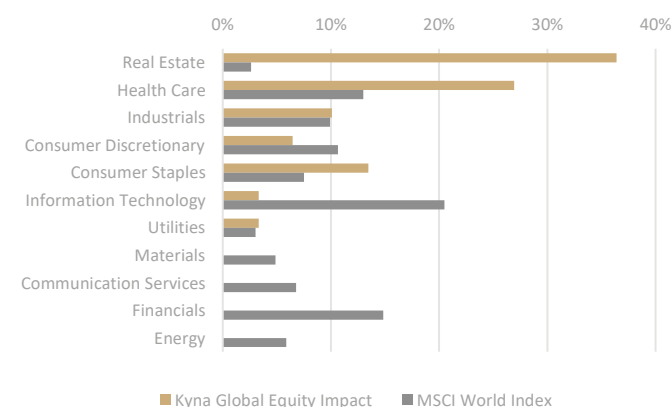
Price chart
